

## About the conference

We warmly invite to an International conference organized by IFA Poland and IFA Germany entitled "Practical aspects of the application of the double tax treaty between Germany and Poland", which will take place in Krakow, Poland on September 25, 2023. The event will be held in English.

The conference will focus on how well or problematically the Polish-German Double Tax Treaty has been functioning over the past years, whether it is in line with the OECD Model Convention or does it deviate from it. and whether it is adequate or not to the actual relations between the two large European economies. Long history of mutual investments, movements of capital and people, have created hundreds of thousands of jobs, strong international companies and modern supply and value chains. By doing so, a rich test-base for most of the provisions of the bilateral Double Tax Treaty has been established. Under the guidance of most renowned tax experts from both countries the conference will give you the insight on which DTT's provisions have worked well and which have caused the most disputes or difficulties and how the disputes resulting from DTT's adoption have been resolved. It will also elaborate on whether the DTT is ready to face the challenges of fast

changing economies of the future.

#### Wieliczka Salt Mine 10 Daniowicza Street, Wieliczka

The Wieliczka Salt Mine is one of the most valuable cultural monuments in Poland. It is also a world-class historical monument and, as such, is registered in UNESCO's First World List of Cultural and Natural Heritage.



## The Abbey of Tyniec Benedyktyńska 37, Krakow

The Tyniec abbey forms approximately a quadrangle with a few courtyards. The church is distinguished by the size, shape and the height of the roof, as if it was supposed to protect from the northern wind. The architecture is located amongst the surrounding trees. It is necessary to check the route on the map.



# Krakow Old Town Rynek Główny, Krakow

The most important sightseeing area of Krakow is the Old Town. The iconic historic sites are located on the Royal Road. This thoroughfare begins at St Florian's Church, crosses the Barbican, a fortified gateway from the fifteenth century, through St Florian's Gate and onto Florianska Street and all along Grodzka Street. The Royal Road passes through Market Square, the main square in Krakow. At the end of Grodzka Street is Wawel Hill and its imposing Castle.
